CONDITIONS OF CONTRACT

- The adopter of the above mentioned animal has paid PESU an adoption fee of ____ euros.

 - ☐ The adopter has paid the adoption fee to a PESU representative in cash.
- The adopter commits to taking good and responsible care of the animal according to the current Finnish animal welfare laws and regulations, and taking the animal to a veterinarian when needed. However, PESU expects all adopters to fulfil higher standards than the minimum required by law.
- PESU shall provide the adopter with information and support concerning the animal's adoption within reasonable expectations. Please note that in the new home and surroundings, the adopted animal may exhibit different behaviour and personality traits.
- PESU reserves the right to follow up on the animal's adoption and well-being by calling or visiting the new home on a pre-arranged moment.
- After reclaiming the animal, PESU releases the full responsibility of the animal listed above to the undersigned adopter. This applies also during the probation period, including all costs regarding the care for the animal. The adopter shall take care of vaccinations and deworming. The animal shall expressly not be allowed to have any offspring. The adopter of a non-sterilized animal shall have the animal sterilized according to the conditions stated in this document. (See 11. Other stipulations.)
- Should the animal run away or die, the adopter must notify PESU immediately. The adopter agrees to keep PESU informed about any changes in his/her personal information (name, address, phone number and email address).
- Should the adopter no longer be able to care for the animal, PESU must be notified immediately. In that case, the adopter agrees to keep the animal, as well as pay for all costs regarding the animal, until PESU is able to make rehoming arrangements. The adopter agrees not to rehome the animal without the consent and approval of a PESU representative, or to have the animal euthanized without a veterinarian's recommendation or an animal welfare-related reason. For any animal returned to PESU after adoption, the adoption fee shall not be refunded to the adopter.
- The adopter agrees to report to PESU on how the animal adjusts to it's new home in ☐1wk ☐1mo ☐3mo ☐6mo ☐12mo after the adoption, to email: elainkuulumiset@gmail.com.
- Rabbits, rodents and birds shall be kept cage-free. Any animal adopted from PESU shall not be kept in a cage. Pack and herd animals must have one or several members of their own species as company. Cats shall only be adopted as indoor cats; they can be outside only on leash or cat safe outdoor enclosures or catios which are escape-proofed.

If the adopter violates or fails to comply with the conditions of this contract, a PESU representative has the mutually agreed right to regain the animal to PESU's care without any liability for recompensation. The penalty fee to be paid by the undersigned adopter for any breach of this contract is 500 euros.

Two identical copies of this agreement have been made, one for each party to the agreement. By undersigning this binding contract both parties accept all conditions and stipulations stated above.
